The [Fall Registration Schedule](#) is now available! Fall registration will start April 5 and go through April 26 with designated timeframes based on student classifications. Please note that the [Fall Class Schedule](#) itself will not be available until March 22.

You have a Registration Hold

Our records indicate you have one or more holds which will prevent you from registering for the upcoming spring semester. Please view your holds on [ASAP](#) and take the necessary steps to resolve them so that you can sign up for classes during your designated registration timeframe.

Admission Hold

You have an admissions hold on your account which prevents registration. Missing transcripts are the most common reason for this hold. Please log into [ASAP](#) to see your outstanding document(s) so you can resolve your hold and register for classes next semester.

Departmental Hold

You have a departmental hold that prevents your registration. Please log into [ASAP](#) to see which department has placed a hold on your account and contact them for a resolution.

Advising Hold

You have a hold that requires you to speak with your Academic Advisor. Please reach out to them to take care of your hold so you can register for classes next semester. Find out more information about your [advising center](#).

Dismissal Hold

You currently need to meet with your academic advisor since you are on academic probation.

Graduate School Hold

You have a hold that requires you to speak with the Graduate School. Please contact the Graduate School at 210-458-4331 to learn more about your hold and how to resolve it.

Health Services Hold

You have a hold with Health Services that prevents registration. Please log into your [ASAP](#) to see what is needed to resolve your hold. If you have any questions, contact Health Services at 210-458-4142.

Financial Hold

You have a financial hold on your account. Please resolve any balances due on your student account by making a payment in [ASAP](#) or contact Fiscal Services at 210-458-8000 (Option 4) for questions.

International Hold

You have a registration hold that is related to you being an international student. Please log into [ASAP](#) to view your hold and complete what is needed. If you have an "International Programs" hold, please contact them at 210-458-7202.

Parking Hold

You have a parking and transportation hold that prevents you from registering next semester. Please contact Campus Services at 210-458-7275 to resolve your hold.

Student Conduct Hold
